Contest Deadline

Contest begins September 1, 2018 and ends September 22, 2018, 3:00 p.m. CST ("Contest Period").

Entry Information and Requirements

- The artist should create an illustration that reflects animals from Latin America.
- Artwork should be original, two dimensional, and no larger than 18x24 inches.
- Entries will be considered based on the judges' views regarding their creativity and originality.
- An official contest entry form must be completed, signed, and taped to the back of the artwork in order to be considered an official entry into the contest. Entries must be received no later than 3:00 p.m. CST on September 22, 2018 (The entry form and artwork are referred to as the "Entry").
- Only one Entry per person is allowed. Entries must be dropped off at the Hispanic Heritage Month Celebration Art table on the North Mall of Brookfield Zoo on September 22, 2018 between 12:00pm and 3:00pm CST.
- The Chicago Zoological Society (referred to as the "Society") and Sponsors, as defined below, are not responsible for any computer, telephone or mechanical error, entrant's inability to access the official entry form/official rules on our website,

injury or damage to participant's or any other person's computer related to or resulting from participation or downloading any material or any other error.

- Winners will be selected at the sole discretion of the judges, and their decision will be final.
- All copies of Entries submitted to the Society are and will remain the property of the Society and will not be returned to the entrants. The Society will not correspond with entrants at any time. Entrants will retain any and all copyrights of their entries.
- Only original unpublished artwork created solely by the entrant will be accepted with a properly completed Entry Form. By submitting an Entry, entrants grant to the Society and its agents, successors, and assigns, and anyone authorized by them, a non-exclusive, perpetual irrevocable, worldwide, royalty-free right and license to use, copy, reproduce, display, perform, distribute, modify, adapt, sell, publish, and/or create derivative works based on or not, to use the Entry in any way, in whole or in part, in any and all media now known or later developed, including on the Society's website, without geographic limitation or additional compensation, except where prohibited by law.

Eligibility

This contest is open only to individuals under the age of 18. Employees, trustees, officers, and volunteers of the Society, and advertising/public relations agencies (referred to as "Sponsors and their Agents") and their immediate family members (spouses, parents, children) and persons living in the households of Sponsors and their Agents are ineligible. No purchase is necessary to enter this contest.

Judging

One winner will be selected from eligible Entries. Finalists will be notified by phone on September 22, 2018 and recognized at the Hispanic Heritage Month Celebration. If a winner cannot be reached by the phone number provided, does not accept or refuses the prize, the prize will be forfeited, and an alternate winner may be selected.

A panel of judges comprised of Society staff and community representatives will select the winner. The judges' decisions will be final and binding. Each Entry will be judged based on originality and relevance to the subject matter specified in contest rules. The winner's parent or legal guardian is required to sign the Chicago Zoological Society 2018 Hispanic Heritage Month Celebration Art Contest Official Entry Form, which includes a publicity release along with the artwork submission. If the affidavit is not signed, any winner's title shall be forfeited, and an alternate winner may be selected.

Awards and Recognition

The winner will be notified on September 22, 2018 and will be recognized at the Hispanic Heritage Month Celebration at Brookfield Zoo on the same day. The winning artwork may be displayed at the offices of Cook County Commissioner Luis Arroyo or Jesus Garcia for the duration of Hispanic Heritage Month. Photographs of the winners may be published in Gateways, the Society's members' publication or other Society publication. The winner's name and their artwork may be posted on the Society's public website, www.CZS.org after the winner has been selected. In addition, photos of winner may be sent to the contest winner's local newspapers for possible publication. Awards are non-transferable.

General Terms

By entering, entrants and/or their parent/legal guardian, if applicable, must agree to: (a) release the Sponsors and their Agents from all liability, injuries, loss and/or damage of any kind arising from their participation in the contest and the acceptance, possession and use/misuse of any prize; (b) be bound by these official rules and the decisions of the judges; and (c) give his or her express permission to be contacted by the Society by email, mail or phone. By submitting an Entry, all entrants consent to the Society's use of their names, photographs, and/or likenesses for advertising, promotional and educational purposes without additional compensation in all media whatsoever, whether or not now known, throughout the universe in perpetuity, except where prohibited by law. All federal, Illinois and local laws and regulations apply. This contest is governed by laws of the State of Illinois without regard to its conflicts of law rules, and, by entering the contest; the entrant hereby consents to venue and to the jurisdiction of the courts in Cook County, Illinois. The Society's failure to enforce any term of these official rules shall not constitute a waiver of such term or any other term of these official rules.
